## **Update on Defined Contribution and 457 Plans**

Vice-President Kravetz introduced Jeremy Chambers and Sarah Rooding from CAPTRUST Financial Advisors who gave a presentation on potential target fund options to be used in both the defined contribution and 457 plans. After reviewing input received from the Library Board and Director and following a rigorous target date selection process, Mr. Chambers recommended replacing the current JP Morgan Target Funds with T. Rowe Price Target Funds. T. Rowe Price Target Funds have a through retirement glidepath, conservative risk tolerance and active management, which meets needs expressed by the Board.

## **Financial Report**

The November 2020 financial statements were accepted.

## **Director's Report**

Director Bohrer reported on the following:

- Oakland County has approved payment of our second reimbursement request of \$22,985 through the CARES Act funding. We have received a total of \$98,305 which covers the majority of our pandemic-related expenses.
- A work at home statement has been added to our Pandemic Preparedness and Response Plan per the recent Michigan Department of Health and Human Services order.
- The communications/marketing specialist position has been posted.
- Outreach to local school districts continues to take place through virtually creative ways developed by the youth services staff.
- Usage of computers during the recent Michigan Department of Health and Human Services order is limited to West Bloomfield residents and contract communities at both facilities. Average time per session is 18 ½ minutes well below the 45-minute time limit.
- Circulation at the Main Library is 74% through *Grab and Go*, 24% through the drive-up window and 2% through curbside service. At the Westacres Branch circulation is 94% through *Grab and Go* and 4% through curbside service.
- Information about the new Director will be distributed through a variety of outlets and an orientation will be conducted during the week of December 14, 2020.

**Whereas, Tom committed countless hours to the Library Board of Trustees and served with distinction in Board positions, including Board Vice-President, Secretary and Treasurer, and**

**Whereas, Thomas Meyer was re-elected to the Library Board of Trustees for his ninth consecutive term on November 3, 2020, and**

**Whereas, the Library Board of Trustees, Director and staff as well as the West Bloomfield community lost a valued Board member and Library advocate on November 22, 2020 with the death of Thomas Meyer,**
